Work behind the scenes has been going on for quite a while on another valuable benefit... an insurance scheme for UFWDA affiliated organizations in the USA.. The basis is a 'public liability' policy for covering 4x4 activities run by clubs and associations.

The proposed insurance will involve filing paperwork identifying the activity and its risks, which will then be assessed by the insurers and a price for the cover advised.

In some countries like Australia and New Zealand, an annual fee is negotiated by the national organization and divided up among the members, typically about \$8 per member. Events are still notified, but only if risks are seen as unusual, will an additional fee be required. UFWDA would be interested to know its members preference ... an overall levy or each event paying? # Mt. Hood National Forest OHV Travel Management Plan

The Forest Service (FS) is asking for your input during a 60-day public review and comment period, which will end on October 28, 2009. Located in northwest Oregon, the Mt. Hood National Forest is proposing to designate a system ofroads, trails, and areas for off~ highway vehicle by class of OHV

and time of year. By designating a system for OHV use, the Forest would comply with 36 CFR Parts 212, 251, 261, and 295 -Travel Management; Designated Routes and Areas for Motor Vehicle Use; Final Rule [Federal Register Vol. 70, No. 216 (2005)]. After the Record of Decision is signed for this project, the Final Travel Management Rule would require all OHVs to remain on these designated routes and area, and no OHV cross-county travel would be pennitted. Four alternatives are considered: No Action Alternative, Proposed Action, and two action alternatives (Alternatives 3 and 4).

As directed by the National Environmental Policy Act (1969), the Forest Service is now seeking comments from individuals, organizations, local and state governments, and other federal agencies that may be interested in or affected by this project. Mt. Hood National Forest is providing a 60~day public comment period for this DEIS, commencing on the date that legal notice is published in the Federal Register on approximately August 28,2009. Written comments must be received by October 28, 2009. Comments will be accepted via mail, fax and einail at the following address.

Comments received in response to this solicitation, including names and addresses of those who comment will be considered part of the public record on the proposed action and will be available for public inspection. Comments submitted anonymously will be accepted and considered; however, those who submit anonymous comments may not have standing to appeal the subsequent decision under 36 CFR Part 215.

The Subcommittee on National Parks, Forests and Public Lands of the U.S. House Committee on Natural Resources held a <a href="hearing">hearing</a> on October 1 to consider <a href="hearing">H.R. 1925</a>, America's Red Rock Wilderness Act of 2009. This legislation -- which will ban off-highway vehicle (OHV) access to public lands to those who live and recreate in Utah -- was introduced by New York Representative Maurice Hinchey. In the White River National Forest, he sees some of the same old battles being fought. For example, conservationists are making a big effort in the Hidden Gems Wilderness Campaign to add 400,000 acres of specially protected lands in Colorado. The majority of those lands, but not all of them, are on the White River. Fitzwilliams would like to redirect that effort into on-the-ground projects, like watershed restoration.

"Making everything Wilderness, or 400,000 acres of Wilderness, I just don't think that's a priority right now,"he said. "The forest is in pretty darn good shape.

"To me, the conservation challenge of the next century is not should we make it Wilderness or not, or should we lease it (for natural gas development) or not, or should this little area be open to ATVs," he said. "The battle is how are we going to collaboratively grow and prosper."

He wants the White River staff and the people in the communities surrounded by the national forest to set their sights on bigger issues, like the health of the national forest and the private lands it borders.

# Chequamegon-Nicolet National Forest MVUM... a WOHVA report

The Chequamegon-Nicolet National Forest is currently working on their first revision of the MVUM. The MVUM displays those roads and trails that are available for public motor vehicle use. The MVUM is available on their website at: <a href="http://www.fs.fed.us/r9/cnnf/MVUM">http://www.fs.fed.us/r9/cnnf/MVUM</a>. Hard copies are also available at no charge at Forest Service offices.

The MVUM is updated annually, with the next update to be available in March of 2010. The Forest Service is currently accepting requests for changes (both additional trails and possible closures) to the MVUM. The comment deadline is November 30th, 2009. Requests need to be extremely specific.

General requests for more or additional trails are of no value. Forest Service Route Numbers and specific map locations must be included along with your requests. Both the Forest Service and WOHVA are available to assist users in obtaining this information.

Currently, the Forest Service has received only a small handful of MVUM change requests. It's disappointing that more Forest users have not come forward with requests for additional roads, trails and routes. Remember, for your favorite routes to be included on the MVUM you have to ask. The world is run by those who get involved.

The Bureau of Land Management's (BLM) Four Rivers Field Office, located in southwestern Idaho, is holding a series of public meetings during the month of October. The purpose of these meetings is to introduce the public to the preliminary alternatives for its new Resource Management Plan (RMP) and to solicit comments.

Some of the preliminary alternatives...

#### **Alternative A: No-Action**

Required as a baseline against which to compare the effects of the other alternatives

\_UFWDA: getting you further down the trail than the price of one tank of fuel

### **Alternative B: Emphasize Resource Conservation**

Emphasizes protecting natural resource values on BLM land from the potential negative impacts of population growth and increased growth

⇔ Protective measures, for plants and wildlife, to address increasing use of public lands

## Alternative C: Accommodate Growing Demand for Public Land Uses

Recognizes population growth as the leading factor for land management decisions in the Four Rivers Planning Area

⇒ Management actions, focused in "core areas" that accommodate population growth (recreation, community expansion, etc.)

## Alternative D: Maximize BLM Management Efficiency

Proposes focused, multiple use of "core areas" for efficient and effective management ⇔ Efforts would concentrate on blocks of BLM land where resources could be more effectively managed
